## **Re: Confirmation of FATCA status**

Dear Sir,

With reference to the United States Foreign Account Tax Compliance Act ("FATCA"), Lombard Odier Funds (Europe) S.A. confirms that, in its capacity as Management Company under Chapter 15 of the Luxembourg law of 17 December 2010 on undertakings for collective investment as well as Alternative Investment Fund Manager under Chapter 2 of the Luxembourg law of 12 July 2013 relating to alternative fund managers, it qualifies as a "Non Reporting Financial Institution" under the "Luxembourg Investment Advisor/Investment Manager" status in accordance with the intergovernmental agreement ("IGA" - model 1) between the Government of the Grand Duchy of Luxembourg and the Government of the United States of America.

As a non-reporting financial institutional under a model 1 IGA, Lombard Odier Funds (Europe)S.A. has not been required to register with the United States Internal Revenue Service ("IRS") and obtain a Global Intermediary Identification Number ("GIIN") as part of its FATCA compliance program.

Lombard Odier Funds (Europe) S.A., on behalf of the Luxembourg Investment Funds listed in appendix A for which it acts as management company or alternative investment fund manager, confirms that such Investment Funds are "Participating Foreign Financial Institutions" for the purposes of FATCA under either a reporting financial institution status or a non-reporting financial institution status.

Reporting financial institutions have registered with the IRS and obtained a GIIN as disclosed in appendix A. Non-reporting financial institutions have elected for the "Collective Investment Vehicle" category in accordance with the IGA and have not been required to register with the IRS and obtain a GIIN.

The Investment Funds, through their sub-funds in case of umbrella structure, comply with the terms of FATCA applicable to them.
